INSTRUCTIONS FOR USE

DILUTION

Trigger Bottle – General Cleaning and Sanitising

Pump Action Dispenser - add water to bottle. Add 2 pump measures to sanitise and clean.

Blend Centre - fill bottle with pre-diluted solution.

Surface Cleaning

1. With pre-mixed solution, spray a fine mist to the surface of CTC ClearTrace Complete via the trigger spray. Wipe away with disposable paper to clean the surface, discard the disposable paper in the waste cycle, repeat the procedure to sanitise, discard the disposable paper in the waste cycle. Application process takes approx. 30 seconds.

DILUTION

Trigger Bottle – Spot and Stains

Used at a dilution rate of 1:1.

With pre-mixed solution, spray a fine mist to the surface via the trigger spray.

Depending of soiling type: Scrub / Blot / Dab / Wipe surface area to remove soiling. Once soiling has been removed wipe away with disposable paper to clean the surface.

Bucket – General Cleaning and Sanitising

Pump Action Dispenser - add water to mop bucket. Add 4 pump measures to the bucket and clean.

Blend Centre - fill bucket with pre-diluted solution.

Floor Cleaning - Manual

- 1. Dose the product into a bucket filled with water and mop the floor to apply the solution.
- 2. Allow the product to act briefly and scrub, brush or mop depending on the type of soiling.
- 3. Remove the soiled solution from the floor with a clean mop.

Floor Cleaning - Machine - Light to Medium Soiling

- 1. Dose the product into the full water tank of a single disc machine or scrubber drier and apply the solution to the floor surface.
- 2. Allow the product to act briefly and scrub, depending on the type of soiling.
- 3. Remove the soiled solution from the floor.

Floor Cleaning – Machine – Heavy Soiling

- 1. Dose the product into the full water tank of a single disc machine or scrubber drier and apply the solution to the floor surface.
- 2. Scrub the floor without wet vacuuming. Allow the product to act briefly depending on the type of soiling.
- 3. Scrub a second time and directly wet vacuum the soiled solution.

DILUTION

Carpet/Extraction Cleaning – Odours and Urine

Pump Action Dispenser - add water to clean water tank. Add 8 pump measures to the clean water tank and clean the area.

Carpet/Extraction Cleaning – Daily Cleaning

Pump Action Dispenser - add water to clean water tank. Add 4 - 6 pump measures to the clean water tank and clean the area.



Carpet/Extraction Cleaning – Historic Urine Contamination

Used at a dilution rate of 1:1

- 1. Soak the carpet area with CTC ClearTrace Complete to ensure the product reaches the inbuilt bacteria within the carpet pile.
- 2. Leave the solution to work for at least 1 (One) Hour.
- 3. Agitate the surface of the carpet with a stiff brush.
- 4. Remove the solution from the surface using an extraction system.
- 5. Repeat if necessary.
- 6. Leave to air dry.
